I agree for myself and successors that the above representations are contractually binding and are not mere recitals, and that should I or my successors assert any claim in connection with this agreement, I or my successors shall be liable for the expenses including attorney fees incurring by the OBS or an officer, member, or sponsor thereof. This agreement may not be modified orally, and a waiver of any provision shall not be construed as a modification of any other provision herein or as consent to any other provision herein or as consent to any subsequent waiver modifications.
